

COOKIES POLICY

This Cookies Policy is an integral part of the Legal Notice and Privacy Policy of the website www.experientigroup.com (hereinafter, the "**Website**").

In order to make it easier to browse the Website, ACTIVIDADES DE OCIO Y EDUCACIÓN, S.L.U. (hereinafter "**EXPERIENTIA**"), as owner of the Website, with registered office at Calle Albasanz 46, 28020, Madrid, Spain, hereby informs you that it uses cookies and/or other data storage and retrieval devices with similar features (hereinafter "**Cookies**").

Therefore, with the aim of guaranteeing the User (hereinafter, the "**User**") all the information required for browsing properly, we provide you with the following information on what Cookies are, the types of cookies used on our Website and how to configure or disable them.

What is a Cookie?

Cookies are files containing small amounts of information that are downloaded to the User's device when visiting a web page. Their main purpose is to recognise Users each time they access the web page, making it possible to improve its quality and offer a better User experience.

Cookies are essential for the operation of the Internet; they cannot damage the User's equipment/device and, if they are activated in the browser settings, they help to identify and correct possible errors in the functioning of the web page.

Types of cookies

Cookies can be classified into different types, based on different criteria:

According to the entity that manages them:

- First-party cookies: These are cookies that are sent to users' devices from a computer or domain managed by the Service editor itself and from which the Service requested by users is provided.
- Third-party cookies: These cookies are sent to the users' devices from a computer or domain that is not managed by the editor of the Service, but by another entity that processes the data obtained through the cookies.

According to their purpose:

- Strictly necessary or required cookies: These cookies are essential for our website to work normally or to access certain features, such as the ability to log in, purchase subscriptions or fill in forms.
Under European regulations, technical cookies and those necessary for the operation of the Website are exempted from the requirement of informed consent

by the User. Consequently, EXPERIENTIA does not need your consent to install on your device the cookies that are necessary to enable the Website's features, and their use is based on the need to provide the services requested. If you disable or block all cookies in your browser, your browsing of the Website may not be optimal and some of its features may not work properly.

- Analytical and web optimisation cookies: Cookies used for analytical purposes to understand how users interact with our service, so it can be improved.
- User preference cookies: Cookies that remember choices made, such as language or region, to provide a personalised experience.
- Advertising cookies: These cookies allow the management of advertising spaces included in the Services, where appropriate.

Use of Cookies by EXPERIENTIA

By accepting the cookie banner that appears when the User starts browsing the Website or by configuring the cookies, the User expressly accepts the use of these Cookies on their devices. If you disable the Cookies, some of the features available on the Website may not work correctly.

Specifically, EXPERIENTIA uses cookies for the purposes described below. If in the future the provider uses other cookies to offer more and better services, Users will be informed about it.
